The latest issues of all JIG Standards have now been published, and we are delighted to announce that in addition to EI/JIG 1530 2nd Edition (May 2019), copies of **JIG Standards 1, 2, 4 and the JIG HSSEMS** are available to purchase online via the Standards & Publications area of the website www.jig.org from today, 16 September 2021.

The Standards are available as downloadable PDF documents, or for delivery as A5-size hard copies. All copy types are priced to the public at £275 per copy for JIG 1&2 and £170 for JIG 4 but we are pleased to confirm that the Member price will be £110 per copy for JIG 1&2 and £65 for JIG 4, with discounts available for bulk orders / mixed hard copy/PDF orders. Enquiries for bulk or mixed hard copy/PDF orders should be made to standards@jig.org. The JIG HSSE MS Standard is free of charge to JIG Members as a PDF and for £5 as a hard copy and priced at £25 for the general public. All prices will be reviewed on 1 January 2022.

Operating to JIG Standards

Locations operating to JIG Standards will continue to be inspected to JIG 1&2 Issue 12 and JIG 4 Issue 3 until 31 December 2021.

From 1 January 2022, locations operating to JIG Standards will be inspected to the latest Issues, with non-compliances recorded as comments. Locations shall comply with the latest Issue requirements in their entirety before 1 January 2023.

The new requirements of the JIG HSSEMS Standard - Issue 3, will take effect on 1 January 2023. A new audit checklist template will be published 1 January 2022. During 2022 only, participating locations/companies may choose to have their audit conducted against either the existing or new checklist.

* JIG is examining the issue of testing the refuelling vehicle Deadman independently when connected to a dual air/lanyard pilot valve. Test rig operators may retain existing lanyard only operated hydrant pit valves until this review is completed.

The latest issues of JIG 1,2 and 4 also contain a number of extra requirements for equipment introduced into service or modified from 1 January 2023. These requirements can be found in the Standard or in the Summary of Changes document.
